Notice of Race

1.0 The Organizing Authority is the Treasure Island Sailing Center (TISC).

2.0 RULES

- 2.1 The regatta will be governed by the Racing Rules of Sailing (RRS) for 2009-2012, including changes effective January 1, 2010 and Appendix D – Team Racing Rules.
- 2.2 RRS 40 will be changed as follows: All competitors are required to wear life-jackets or other adequate personal buoyancy while on the water except for short times to adjust or change clothing. The “Y” will not be displayed.

3.0 ELIGIBILITY AND ENTRY

- 3.1 Vanguard 15 (V15) boats conforming to the V15 Class association rules may be entered by completing the entry form and returning it with fee prior to the first start of the regatta to the Regatta Chair.
- 3.2 All sailors MUST have a current TISC Medical & Liability Form on file BEFORE racing.

4.0 FEES

- 4.1 Clinic fee is \$25, payable in cash or check made out to TISC.
- 4.2 Regatta fee is \$50 if entry is received by August 13, payable in cash or check made out to TISC.
- 4.3 Regatta fee is \$60 if entry is received after August 13.

5.0 SCHEDULE

- 5.1 A coached team racing clinic will be held the morning of Saturday, August 21, 2010.
 - 5.1.1 Registration will be open until 9:00 AM in the TISC Club House.
 - 5.1.2 Clinic will begin at 9:00 AM in the TISC Club House.
- 5.2 The fleet racing portion of the regatta will be held the afternoon of Saturday, August 21, 2010.
 - 5.2.1 Registration will be open until 1:00 PM in the TISC Club House.
 - 5.2.2 Competitor's Meeting will be held at 1:00 PM in front of the TISC Club House.
 - 5.2.3 First Warning will be at 2:00 PM.
 - 5.2.4 No race will be started after 5:00 PM.
 - 5.2.5 A minimum of 3 races shall constitute a Regatta, and results will determine teams for the team racing portion of the regatta.
- 5.3 The umpired team racing portion of the regatta will be held Sunday, August 22, 2010.
 - 5.3.1 Competitor's Meeting will be held at 9:00 AM in front of the TISC Club House.
 - 5.3.2 First Warning will be at 10:00 AM.
 - 5.3.3 No race will be started after 3:00 PM.
 - 5.3.4 A minimum of 2 round robins shall constitute a Regatta.
- 5.4 Pre-registration is encouraged on the Vanguard 15 website (<http://vanguard15.org/schedule/597>).

6.0 SAILING INSTRUCTIONS and NOTICES TO COMPETITORS

- 6.1 The Sailing Instructions will be available at registration and during the Sailor's Meeting.
- 6.2 All changes to the Sailing Instructions AND/OR Notices to Competitors will be published on the notice board located across from the Harbormaster Shack.

7.0 RACING AREA & COURSES

- 7.1 The intended racing area will be Clipper Cove utilizing temporary inflatable marks.
- 7.2 Both fleet racing and team racing will use a Digital-N course.
- 7.3 A 3-minute Sound-Signal Starting System will be used without visual signals.

8.0 SCORING & AWARDS

- 8.1 The fleet racing portion of the regatta will be scored according to Appendix A of the RRS, and the team racing portion of the regatta will be scored according to Appendix D.
- 8.2 Awards will be given for first – third place in fleet racing and for the winning team in team racing.
